

## COOKIE POLICY

This Cookie Policy governs the use of cookies on the website (<https://www.kvx.no>, hereinafter: “Website”) of Komatsu KVX LLC. (hereinafter: “KVX”, “we”, “us”, “our”).

A cookie is a small text file that a website saves on your computer or mobile device when you visit the site and which contain certain information and sometimes personal data. It enables the website to remember your actions and preferences (such as login, language, font size and other display preferences) over a period of time, so you don't have to keep re-entering them whenever you come back to the site or browse from one page to another.

Social media plugins are small pieces of software developed and provided by social media service providers (e.g. Facebook, LinkedIn, Google, YouTube, Pinterest, Instagram and Twitter), which add social media integration when built into the Website.

Pixels are also small pieces of software developed and provided by advertisers and social media service providers, which are integrated into the Website in order to provide you with more relevant advertisements, tailored to your interests.

## 1. IN GENERAL

1.1. Your personal data are processed by Komatsu KVX LLC, a corporation organised and existing under the laws of Norway, with registered office at Plogfabrikkveien 9, N-4353 Klepp stasjon, registered in Norway under Register number NO 979 987 420. 1.2. Any notion starting with a capital shall be defined by explicit reference in this Cookie Policy. Where possible given the context, singular words shall be interpreted as also including the plural and vice versa.	To make sure we have the same understanding of what is written here, it is important that certain notions are interpreted in the same way by you and by us.
1.3. Where reference is made to certain laws or regulations, such reference shall also include any change, replacement or annulment of said laws or regulations, including any related executive decisions.	Laws tend to change from time to time, and we want to make sure that this Cookie Policy remains in line with any such changes.
1.4. KVX reserves the right to modify, change or amend this Cookie Policy at its own discretion and from time to time. Such modification, change or amendment shall be communicated via the Website. These cookies are needed for the Website to work properly and to give you a good user experience.</p> <p>An example is the cookie used to remember your language setting.</p>
<ul style="list-style-type: none"> <li>• Marketing cookies <ul style="list-style-type: none"> <li>○ <b>Bluekai:</b> The cookies placed by Oracle are the “bkdc” and “bku” cookies. These cookies enable K VX to personalise its marketing campaign.</li> <li>○ <b>Semasio:</b> The cookie placed by Semasio is the “SEUNCY” cookie. This enables K VX to personalise its marketing campaign.</li> <li>○ <b>Tapad:</b> The cookie placed by Tapas are the “TapAd-</li> </ul> </li> </ul>	<p>K VX uses several cookies for marketing purposes.</p>

This cookie enables K VX to personalise its marketing campaign.</li> <li>○ <b>match.rundsp:</b> The cookie placed by RUN is the “RUN_ID”-cookie. This cookie enables K VX to personalise its marketing campaign.</li> <li>○ <b>Doubleclick:</b> The cookie placed by Doubleclick is the “IDE”-cookie. This cookie enables K VX to personalise its marketing campaign.</li> <li>○ <b>Adsrvr:</b> The cookies placed by TheTradeDesk are the “TDID”, “TDCPM”-cookies. These cookies enable K VX to personalise its marketing campaign.</li> </ul>	
<ul style="list-style-type: none"> <li>• Analytical and statistical cookies <ul style="list-style-type: none"> <li>○ <b>Google Analytics:</b> The cookies placed by Google are the “_ga”- (2-year lifespan), as well as the “_gid”/“_gat”-cookie (1-day lifespan). It enables K VX to learn information about our users’ use of the Website, such as the time of visit, the pages viewed, whether the user has visited the Website before, and the website visited prior to visiting the Website. This information can be used to make the Website better so as to give you a better user experience.</p>

In the light thereof, cookies can be set in order to allow you to view the video clips shown on our Website.</li> <li>○ <b>Addthis:</b> The AddThis sharing platform and the third party social media websites that you may use to share links from the site may place cookies on your computer, namely the ‘_atuvc’, “atuv”, ‘loc’, ‘mus’ and ‘uid’ cookie. K VX does not have any control over the way that these websites use your data. You should read their respective privacy policies carefully to find out what happens to any data that these services collect when you use them. 3.2. K VX processes your personal data to provide you in a personalized and efficient way with the products and services, via the Website.	This provision is self-explanatory.
3.3. K VX processes your personal data for marketing purposes, i.e. to provide you with targeted communications, promotions, offerings and other advertisements of K VX regarding K VX's products and services.	This provision is self-explanatory.
3.4. K VX may process your personal data for informing any third party in the context of a possible merger with, acquisition from/by or demerger by that third party, even if that third party is located outside the EU.	This provision is self-explanatory.
3.5. K VX may process your personal data for the preservation of the legitimate interests of K VX, its partners or a third party if and when your registration with, or use of, the Website can be considered (a) a violation of any applicable terms of use or the intellectual property rights or any other right of a third party, (b) a threat to the security or integrity of the Website, (c) a danger to the Website or any of K VX's or its subcontractors' underlying systems due to viruses, Trojan horses, spyware, malware or any other form of malicious code, or (d) in any way hateful, obscene, discriminating, racist, slanderous, spiteful, hurtful or in some other way inappropriate or illegal.	Here we reserve the right to process your personal data if you use our Website in any way that may harm K VX or someone else or is illegal.

**5. RECIPIENTS**

<p>5.1. KVX does not send your personal data in a directly identifiable manner to any third party without your explicit permission to do so. You understand, however, that our use of analytical and statistical as well as social media cookies may imply that the third party providers of those cookies may obtain certain information about you, including about your surfing behavior. You can find more information in the respective policies of those providers.</p>	<p>We do not share your personal data with third parties in a way that those parties can identify you directly unless you consent to it or unless we have anonymized your personal data. You understand however that when you use Facebook for instance to communicate, Facebook also processes your personal data.</p>
<p>5.2. KVX relies on third party processors to provide you the Website as well as to process your personal data on our behalf. These third party processors are only allowed to process your personal data on behalf of KVX upon explicit written instruction of KVX. KVX warrants that all third party processors are selected with due care and are obliged to observe the safety and integrity of your personal data.</p>	<p>Our Website may be developed, maintained or hosted by third parties. Similarly, we rely on the services of third parties such as cloud providers to process your personal data internally.</p>



## 6. QUALITY ASSURANCES

6.1. K VX does its utmost best to process only those personal data which are necessary to achieve the purposes listed under the purpose for processing.	We will not process more personal data about you than we need for the purposes we have communicated to you.
6.2. Your personal data are only processed for as long as needed to achieve the purposes which are described above or up until such time where you withdraw your consent for processing them. Note that withdrawal of consent may imply that you can no longer use the whole or part of the Website. K VX will de-identify your personal data when they are no longer necessary for the purposes outlined in the purpose for processing, unless there is: <ul style="list-style-type: none"><li>• an overriding interest of K VX or any other third party in keeping your personal data identifiable;</li><li>• a legal or regulatory obligation or a judicial or administrative order that prevents K VX from de-identifying them.</li></ul>	Here we explain how long we will keep your personal data in a way that allows us to identify you.
6.3. K VX will take the appropriate technical and organizational measures to keep your personal data safe from unauthorized access or theft as well as accidental loss, tampering or destruction. Access by personnel of K VX or its third party processors will only be on a need-to-know basis and subject to strict confidentiality obligations. You understand, however, that safety and security are best efforts obligations only, which can never be guaranteed.	We are committed to keeping your personal data safe.

## 7. YOUR RIGHTS

<p>7.2. You have the right to ask that any personal data pertaining to you that are inaccurate, are corrected free of charge. If a request for correction is submitted, such request shall be accompanied of proof of the flawed nature of the data for which correction is asked.</p>	
<p>7.3. You have the right to withdraw your earlier given consent for processing your personal data.</p>	
<p>7.4. You have the right to request that personal data pertaining to you will be deleted if they are no longer required in light of the purposes which are outlined above or if you withdraw your consent for processing them. However, you need to keep in mind that a request for deletion will be evaluated by KVVX against:</p> <ul style="list-style-type: none"> <li>• overriding interests of KVVX or any other third party;</li> <li>• legal or regulatory obligations or administrative or judicial orders which may contradict such deletion.</li> </ul> <p>Instead of deletion you can also ask that KVVX limits the processing of your personal data if and when (a) you contest the accuracy of that data, (b) the processing is illegitimate or (c) the data are no longer needed for the purposes which are outlined above, but you need them to defend yourself in judicial proceedings.</p>	
<p>7.5. You have the right to oppose the processing of personal data if you are able to prove that there are serious and justified reasons connected with his particular circumstances that warrant such opposition.</p>	
<p>7.6. You have the right to receive from us in a structured, commonly used and machine-readable format all personal data you have provided to us.</p>	



7.7. If you wish to submit a request to exercise one or more of the rights listed above, you can send an e-mail to us at [kvx@kvx.no](mailto:kvx@kvx.no) for all data subject rights matters. An e-mail requesting to exercise a right shall not be construed as consent with the processing of your personal data beyond what is required for handling your request. Such request should clearly state and specify which right you wish to exercise and the reasons for it if such is required. It should also be dated and signed, and accompanied by a digitally scanned copy of your valid identity card proving your identity.

KVX will promptly inform you of having received this request. If the request proves valid, KVX shall notify it as soon as reasonably possible and at the latest thirty (30) days after having received the request.

If you have any complaint regarding the processing of your personal data by KVX, you may always contact KVX via the e-mail address mentioned in the first paragraph of this clause. If you remain unsatisfied with KVX's response, you are free to file a complaint with the competent data protection authority, i.e. the Belgian data protection authority.
